2. Where Does This Privacy Policy Apply?

But hey—sometimes, certain features may have their own privacy rules. If that happens, you'll see a separate policy pop up, and what it says will apply. No surprises—we'll always keep you in the loop.

3. The Data We Collect

Every time you use our service—when you log in, how often you use certain features—some data is created automatically. Don't worry, we're not spying on you; we just want to personalize your experience.

Also, if you log in to BonkList via another platform (e.g., Facebook, Google, or Apple) or choose to upload info from your account on that platform, we may collect data from there too. (Thanks, technology!)

Photos, videos, voice recordings, messages basically, anything you express yourself with! With these, we get to know you better and make your experience uniquely yours. You take the stage; we set the lights and music.			
Purchase Data	When you buy something or accept a "challenge accepted!" moment Whether you purchase a feature or jump into a challenge—we track that action. What you got, when you got it, how much you paid it's all recorded. But don't worry—we won't stick it on a wall paper. Depending on how you pay, the data may vary. If you pay directly with us (not via IOS or Android's system), you may need to provide financial details like your bank or credit card number. In short, we won't snoop around your wallet. But to do amazing things with you, we need to know the what, when, and how much.			
Marketing, Survey & Research Data	Every now and then, we like to ask for your opinion—or entertain you! We may run surveys for research, focus groups, or market checks. Sometimes we turn it into pure entertainment: promos, events, raffles, contests You win, we learn. If you choose to take part, we collect your info, responses, and feedback. Knowing what you think matters to us —it helps us offer a better experience and grow our community.			
Third-Party Data	If you choose to share info about someone else with us—like providing a friend's contact for a feature, or sending feedback or a report about a user—we process these data on your behalf to fulfill your request. If you're curious about how we handle the data of non-users, click here for full transparency.			
Customer Support Data	When you contact us, we ask for info that may be necessary to address your question or issue. Other users may also contact us with reports

	Also, if legally permitted, we may receive info from third parties about suspicious or convicted individuals to protect our community. 7. Cross-Border Data Transfers

The BonkList universe isn't limited to your neighborhood — it's a global playground!

So, as explained in Section 5, some of your data may be transferred to countries with different data protection laws — including the United States.

But don't worry! If we ever need to transfer your data outside the countries like the European Economic Area (EEA), the United Kingdom, or Switzerland — where strict data protection rules apply — we rely on strong legal safeguards called **Standard Contractual Clauses** (SCCs). These are official commitments made between us and the parties we share data with, to keep your data safe.

Example: If you ask for a copy of messages from someone else, we'll need **them** to make that request themselves. (We're not in the gossip business)

What If We Say No?

You've got the right to object!

Just get in touch, mention it's a "Privacy Request Appeal", and share the details.

Still not satisfied with the outcome? You can also reach out to your local data protection authority.

Living in the **EEA or the UK**?

That means you also have the right to file a complaint with the relevant regulator.

Long story short:

Your data, your rights.

9. How Long Do We Keep Your Data?

Do Your Data Live Forever?

We wish BonkList connections could last forever...

But when it comes to your data, things work a little differently.

We only keep your information for as long as necessary and as allowed by law. Simple, transparent, and totally under control!

What Happens When You Say Goodbye?

If you decide BonkList isn't your vibe anymore:

- You can **close your account** (No hard feelings but we'll miss you!).
- If you're inactive for two years, we'll quietly close your account (no drama, we promise).

So... How Long Do We Hold On to Your Data?

1. For Security Reasons:

After you close your account:

- We retain certain data for at least 3 months,
- Or for 1 year if the account was banned for breaking rules.

Why? To protect our community from bad behavior — BonkList's shield is always up!

2. For Legal Requirements:

- Transaction and billing data: 10 years
- Credit card data: As long as needed for dispute periods
- Traffic/log data: 1 year
- Consent records: 5 years

3. For Our Business (But Always With You in Mind!):

- Customer service records: 6 years
- Estimated download/purchase location: 5 years
- Account/subscription history: Deleted 3 years after account closure
- Profile data for legal defense: 1 year
- Security-related exceptions: As long as strictly necessary

4. In Special Cases:

If there's a legal dispute, investigation, or formal request, we might need to hang on to some data. Our legal team makes sure we play by the rules.

What About Anonymous Data?

If the data can't identify you directly and the law allows it, we might use it to:

- Improve the service
- Develop new features
- Strengthen platform safety
